Accept Fireman's Fund Heritage Grant in the Amount of \$10,163 and Approve a

Budget Adjustment

DESCRIPTION

This Staff Note requests the approval to receive a Heritage Program by Fireman's Fund Grant and approve Staff's spending proposal.

STAFF RECOMMENDATION

Staff recommends that the Board approve the following motion:

Motion: I move that the Board accept the donation of \$10,163 from the Fireman's Fund Insurance Company, approve a budget adjustment to appropriate it to pertinent accounts in Fund 301 – Operating Expenditures and ratify the application as submitted by the General Manager.

DISCUSSION

On May 7, 2015, CAL FIRE/SLO County Fire Department was notified that a grant request had been submitted by local landowner John A. Hamby, Managing Director of DeWitt Stern of California Insurance Services. DeWitt Stern works with Fireman's Fund Insurance Company on a variety of projects. Together, they nominated the South Bay Fire Department (Station 15-South Bay) to receive a \$10,190 grant, with the request that it be used to benefit emergency response in the Los Osos area. Chief Robert Lewin notified Station 15 – South Bay of the grant. Staff immediately began the process of collecting and submitting documentation to complete the grant application by the May 20, 2015 deadline.

Staff submitted an application for this grant proposing to split the funds four ways:

- Fire Safety Tools: 52 dual CO2/Smoke Detectors with 10 year battery:
 - ❖ 52 @ \$43.19 ea. (tax/shipping included) = \$2,246

- Fire Safety Education: CPR/AED Course:
 - 20-25 students @ little to no cost per person = \$1,000
- Fire Safety Tools: Mine Safety Appliances (MSA) Self Contained Breathing Apparatus (SCBA) bottles:
 - ❖ Two (2) 4500 lb. MSA SCBA bottles @ \$840 ea. (tax/shipping included) = \$1,680
- Fire Safety Tools: Structural Personal Protective Equipment (PPE):
 - Two (2) full sets of PPE's @ \$2,618.50 ea. (tax/shipping included) = \$5,237
- This equals a total of: \$10,163.00.

On May 19, 2015, Station 15 – South Bay Staff met with Miner's Ace Hardware (Los Osos) Management and confirmed that they will provide a 20% discount per detector, which has been incorporated into the cost noted above.

On May 27, 2015, Station 15 – South Bay received notification that its grant application had been accepted and processed and the funds were forthcoming.

Throughout the process, Staff has worked with General Manager Kivley, who has been supportive of the grant as well as Staff's recommendations for its expenditure.

FINANCIAL IMPACT

The above motion and acceptance of this grant should not affect the Fund 301 budget, either positively or negatively. All revenues received from the Fireman's Fund Heritage Program will be offset with corresponding expenditures.

The Department must notify Company within 60 days of receipt of funds if it decides to purchase a different quantity of items than what was awarded by Company, or if it chooses to apply funds differently than originally intended or approved by Company. Unused funds must be returned to Company.

If the Department plans to use funds for any purpose other than originally outlined and approved by Company, the Department must first obtain approval from Company. In the event that the funding is not utilized for the purpose(s) approved by Company and/or outlined in the original application and Company is not notified of any changes to the original request, Company reserves the right to revoke the funding or donation, request the return of the full donation amount, and eliminate the Department from consideration for future funding through the Heritage Program.

It is the intention of Company to promote the donation and Company will work with the Department on promotional efforts to ensure that they are mutually beneficial. If the Department is awarded a grant or donation, Company expects the Department to participate in a check presentation ceremony that is scheduled mutually, but held within three months after the check is received and/or when the equipment arrives. Company reserves the right to film and/or photograph the award presentation and publicize the request and award in all internal and external marketing and communications activities related to the Company Heritage Program. Company will provide stickers to the Department which indicates that the

For large donations such as fire safety houses, Company has the right to assist the Department with design and signage on the equipment and may provide additional funding for this purpose. * 8. Detailed Request

The South Bay Fire Department (SBFD) requests funding through the Fireman's Fund Insurance grant to provide for the following equipment and programs.

- 1. 52 dual CO2/Smoke Detectors with 10 year batteries (compliant with California Senate Bill 745) to be distributed to low-income and/or senior residents in Los Osos, CA. South Bay Fire Department Staff has spoken with Miner's Ace Hardware management and confirmed that they will provide a 20% discount per detector, pending this grant award. See Note below for further information.
- 2. A CPR/AED Course for approximately 20-25 residents, to be funded at little to no cost to the student. In FY 2013/14, South Bay Fire partnered with Central Coast CPR to host a community-wide CPR/AED Course for 24 students at minimal cost. Central Coast CPR, in kind, reduced the cost per student by 33%, equaling \$50 per person. The attached receipt reflects this charge. South Bay Fire has reached out to Central Coast CPR to partner for a like course, pending this grant award. At the time of online application submission, Central Coast CPR has not yet confirmed this price, however South Bay Fire does not anticipate a price change. South Bay Fire hosted this course in FY 2013/14 at the South Bay Community Center free of charge. South Bay Fire has recently spoken with the South Bay Community Center Facility Manager and has an agreement to use the facility free of charge in FY 2015/16 for the purposes of this course, if awarded this grant. See Note below for further information.

Note: The average age of a Los Osos resident is 47.2 years (www.city-data.com); approximately 15 years higher than the average California resident (32.1 years). With a high percentage of elderly and disabled population, Los Osos is home to over 80% of skilled nursing facilities in San Luis Obispo County, as well as four mobile home parks in the District. As the primary response agency to over 14,000 residents, these statistics present a unique challenge to educate residents in first-aid medical care and home safety. SBFD is not aware of any public CPR/AED courses that are provided in the area, yet we receive several requests annually for this training.

Fire protection to the community is provided by the Los Osos Community Services District (LOCSD) through the South Bay Fire Department, the sole fire department within Los Osos, with the secondary responding agency being 2.3 miles away (City of Morro Bay). Los Osos is largely a bedroom community for San Luis Obispo, which is 10.6 miles east, and to a lesser extent, Morro Bay, to the north. Because of its isolated location, access to or from Los Osos is limited, with just two roads connecting Los Osos to other communities: South Bay Boulevard, which leads to Morro Bay via Highway 1, and Los Osos Valley Road, which leads to San Luis Obispo. Inclement weather and road construction occasionally forces the closure of a route, possibly requiring detours to arrive at one's destination. It is possible that the community could be cut off completely should both access roads be cut off.

3. SBFD has twenty-five 4500 lb. MSA SCBA bottles currently, which includes 10 loaners from another fire department. In order to staff our emergency rescue vehicles with the thirty-five necessary bottles and return the loaner SCBA's, SBFD needs to purchase at least 4 to 5 MSA SCBA 4500 bottles annually. Staff believes that this will keep stock in rotation and increase the total number to meet the target of thirty-five SCBA bottles in the next couple years. The current draft fiscal 2015/16 budget does not contain sufficient funds to purchase the 4 to 5 that are necessary. If approved, this grant would provide 2 additional SCBA 4500 bottles in addition to the 3 bottles that are proposed within the SBFD 2015/16 budget, to meet our minimum requirements.

4. Two full sets of Structural Personal Protective Equipment (PPE), which includes helmet, goggles, shroud, nomex hood, turnout coat, leather structure gloves, bunker pants with suspenders and leather structure boots. The South Bay Fire Department Reserve Firefighter Program includes twenty-five firefighters that augment permanent firefighters on the fire engines daily and provide surge protection in the event of large incidents. The SBFD PPE budget provides for replacement of some structural PPE gear, as well as station uniforms and wildland fire PPE and is currently under-funded. If approved, this grant would provide 2 full structural PPE's for 2 of the 7 firefighters hired in the spring of 2015.
