### DESCRIPTION

Authorize the cancellation of all District debit cards and approve the issuance of credit cards to the General Manager, Administrative Services Manager, Water Resource Crew Leader, Fire Chief, and Fire Administrative Assistant.

## STAFF RECOMMENDATION

Staff recommends that the Board adopt the following motion:

Motion: I move that the Board adopt Resolution 2017-13 approving the issuance of five (5) District credit cards and direct Staff to complete all necessary forms for submission to Rabobank and cancel the debit cards.

### DISCUSSION

As some of our debit cards have been compromised, Rabobank has recommended that the District use credit cards which offer better protection against fraud. There are federal protections with credit cards that would limit District losses.

These credit cards are replenished on a monthly basis only.

# **FINANCIAL IMPACT**

This has no financial impact as the current debit cards will be canceled and balances simply transferred to another type of Cash, which is the imprest balance on the credit card.

- 4. Issue a credit card to Administrative Services Manager Ann Kudart with a spending limit of \$3,000.
- 5. Issue a credit card to Fire Administrative Assistant Harmony Brown with a spending limit of \$3,000.
- 6. Cancel all District debit cards.
