9. DIRECTOR COMPENSATION *(amended and adopted 02/04/2021)*

- 9.1 Each Director is authorized to receive one hundred dollars (\$100.00) as compensation for each regular, adjourned or special meeting of the Board of Directors, each required training session, each Standing Committee meeting of which said Director is either the Chairperson or Vice Chairperson, each ad Hoc Committee meeting, each non-District meeting assigned by the Board President to a Board member at the beginning of each calendar year or other function/meeting attended by him/her as a representative of the District at the direction of the Board of Directors.

On Thursday, July 22, 2021, I attended the monthly Los Osos Community Advisory Council meeting via Zoom to give the update on the CSD activities for the month. Preferring to start with good news, I mentioned the opening of the 7th Street to Ferrell multi-use pathway. Everyone was pleased with this project. I continued with the good news regarding the opening of bids for the 8th Street well project and the completion of the comment period for the Program C well environmental review.

I then mentioned that the CSD was in the process of evaluating the need to switch to a district-by-district election, similar to the way that LOCAC elections are run. Most governmental entities that haven't already made this switch were put on notice recently that we needed to at least study this issue and the CSD has hired a consultant to assist with this study. I found out that the Port San Luis Harbor District had indeed been filed with a lawsuit.

The draft of the water purveyors' letter to the County regarding the proposed ADU (accessory dwelling unit) ordinance was the last item on my report. The UAC had just reviewed the draft letter the day before and recommended sending it on to the Board. I gave a brief summary of the letter and it was pointed out by a member of LOCAC that the draft letter was already on the CSD website under the UAC meeting minutes. I appreciate the efficiency.

The topic of water supply was mentioned several times during public comment. LOCAC actually had an agenda item regarding a "Guesthouse" and bedroom addition. Somehow using the word Guesthouse instead of ADU made the project acceptable and they recommended that the County approve the project.

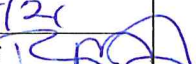

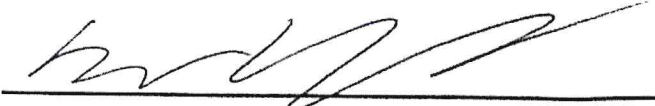

**Los Osos Basin Management Committee
July 21, 2021**

The primary focus of this Basin Management Committee meeting was to discuss provide direction to staff as to how to move forward with developing process and procedures to determine the Sustainable Yield annually in order to be consistent with the requirements of the Stipulated Judgement.

To meet the requirements of the SJ to determine the Sustainable Yield on an annual basis the following process was proposed and discussed in detail and ultimately approved.

1. Beginning in July of a given year, BMC Staff will evaluate the need to develop an updated Sustainable Yield for the upcoming year based on changes in Basin Plan infrastructure, groundwater inflow or outflow parameters, the understanding of hydrogeologic or geologic features in the basin or other factors.
2. BMC Staff will then provide a recommendation to the BMC on whether or not to update the Sustainable Yield_x and the reasoning for that recommendation.
 1. If the recommendation is to update the Sustainable Yield, then recommendations for which parameters to modify from the previous Sustainable Yield will be provided.
 - i. If the BMC approves the proposed update to the Sustainable Yield and the recommended update parameters, BMC Staff will perform the updated Sustainable Yield calculation and bring the results back to the BMC for consideration and approval.
 - ii. If the updated Sustainable Yield results are unanimously approved by the BMC then the updated Sustainable Yield will be documented in the Annual Report for that Year.
 2. If the recommendation is to not update the Sustainable Yield and the BMC agrees, then the Sustainable Yield will remain the same as the previously approved Sustainable Yield by the BMC.
