DESCRIPTION

The Program C groundwater test well will be located at Los Osos Middle School (LOMS) in the parking area for the recreational fields (Pismo Avenue right of way, east of South Bay Boulevard). The test well will be a 10" diameter 320-foot test hole and 300-foot depth 5" diameter PVC groundwater test well. This well will be drilled, constructed and developed, and then destroyed immediately following completion of the well testing. The results of this test well will be used to document the suitability of installing a future municipal groundwater supply well in this vicinity. The well will be installed on County right-of-way (Pismo Avenue), and the work will be conducted under the District's current blanket encroachment permit with the County.

SUMMARY OF STAFF RECOMMENDATION

This item will be approved along with the Consent Calendar unless it is pulled by a Director for separate consideration. If so, staff recommends that the Board adopt the following motion:

Motion: I move that the Board direct staff to award contract to the lowest responsive, responsible bidder, Filipponi and Thompson, in the amount of \$54,500, with a 10% contingency for a total construction authorization of \$60,000.

DISCUSSION

Project Plans and Specifications for this test well were prepared by Cleath-Harris Geologists and Wallace Group, and the project was bid in September/October 2019, with bid opening October 15, 2019. A total of four bids were received. The three lowest bids were evaluated, and the lowest responsive bidder was determined to be Filipponi and Thompson, with a bid of \$54,500. The engineer's estimate for this project was \$60,000. The bid evaluation summary report is attached to this staff report.

FINANCIAL IMPACT

The project construction cost for this test well was estimated at \$60,000. With the recommended low bid of \$54,500, and a 10% construction contingency, this Project will be at the budget established for the Work. It is also noted that Cleath-Harris Geologists was already awarded a contract for \$9,500 for this Project, and has sufficient funds remaining to provide consulting services to see this Project through construction.

SUMMARY: The lowest, responsive, responsible bidder for the subject Project is determined to be Filipponi & Thompson. Wallace Group recommends award of this Project to Filipponi & Thompson, in the amount of \$54,500.

Background

Bids for the subject Project were received and opened on Tuesday, October 15, 2019, at Wallace Group's office. A total of four bids were received, and the bid opening summary is attached to this memorandum. Bids from the three lowest bidders (Filipponi & Thompson, Nor-Cal Drilling, ABC Liovin Drilling) were reviewed in detail, for compliance with the bidding instructions and overall bidding requirements. The table on Page 2 of this memorandum summarizes the bid analysis and results.

All three bids and bidders were deemed responsive. F&T had minor discrepancies in unit prices, but overall costs for these items were in line with other bids and the total line item prices not deemed in error. F&T's bid of \$54,500 in the written form is the bid amount accepted.

The Engineer's Estimate and budget for the construction of this Project was established at \$60,000.
