WHEREAS, the majority of vendors no longer service or repair this type of SCBA equipment, making it increasingly difficult to maintain the SCBA compliment; and

WHEREAS, CAL FIRE staff and District management agree, and recommend replacement of the SCBA compliment to the Board; and
