GENERAL STAFF ACTIVITIES

Staff has been working on the transition between General Managers. I have been meeting with Ron Munds to discuss current duties, updates on reports and current projects in progress. We have several meetings planned to insure a smooth transition. Mr. Munds has been scheduled for training and agencies have been notified and given updated contact information.

LOW INCOME ASSISTANCE FUND

At the December 2018 meeting, staff was given direction to keep the Low Income Assistance Fund Program for sewer laterals open until all residents had completed their sewer lateral hook-up. In June, I received two calls from residents. One resident is in the process of completing their application. At the time of this report, I had not received any other applications. The County is actively advising the residents of our program.

There is a remaining \$109,015.64 in the Community Foundation Fund Account and \$10,477.89 in the Los Osos Low Income Assistance Fund checking account with the District. A check has been written to the Los Osos CSD for the District's time and expenses in the amount of \$1,068.87. The current bank statement, foundation statement, check register and detailed account of time and expenses is attached. The check to the District has been deposited and is included in the June Revenue vs Expense Report.

PG&E POSSIBLE ELECTRICITY SHUT DOWN

The County has been working with the Cities, Special Districts and Emergencies Service providers on how to prepare the residents in case of any electricity shut down. Staff has prepared a flyer that can be distributed to the public to help them prepare for any possible shut down. Our District water facilities are equipped with generators and should have no interruption of services.

PREPARING FOR PUBLIC SAFETY POWER SHUTOFF

Pacific Gas and Electric (PG&E) has made an effort to notify all electrical customers of the potential need to implement Public Safety Power Shutoff (PSPS) events. These possible electrical shutoffs could potentially impact the community of Los Osos in the coming months. Electricity for Los Osos is transmitted through high voltage PG&E electrical infrastructure. To protect communities from the threat of wildfires PG&E will be implementing the PSPS as precautionary measures this coming fire season. If the threat of fire danger conditions threaten the electrical infrastructure, PG&E will be shutting off power at the high risk transmission lines, resulting in power outages for Los Osos.

PG&E has informed the government agencies that the PSPS events could last a minimal of 48 hours with potential for longer periods. Some factors that could initiate the PSPS are:



HIGH WINDS (including red flag warnings)



LOW HUMIDITY



DRY VEGETATION (on the ground and live fuels)



FIRE THREAT (to electrical infrastructure)

ON-THE-GROUND REAL TIME OBSERVATIONS

Los Osos Community Services District (LOCSD) and other government agencies will be given minimal notification of the PSPS and will take action immediately. The priority of the LOCSD is to ensure the customers of the LOCSD Water District will be provided with a safe adequate supply of potable water. The LOCSD has the ability to produce and maintain a 3-5 day supply of water for its customers. During these outages it will be imperative for customers to conserve water usage and minimize waste. Some ways to conserve usage are:

- Shutoff all irrigation systems
- Do not water outdoor lawns or wash vehicles
- Flush toilets less frequently
- If possible delay usage of washing machines and dishwashers

Residents of Los Osos should also take other precautionary measures to ensure they are prepared for a PSPS event. For information about other utilities and other information to help prepare for these events:
