SUBJECT: Agenda Item 8A- 01/06/2022 Board Meeting

Adopt Resolution No. 2022-02 Establishing Voting Divisions and

Boundaries for the Five Board of Directors Districts.

DESCRIPTION

At the December 2, 2021 Board meeting, the Board selected Map 3A as a final districting map. Staff was directed to return to the Board on January 6, 2022 with a resolution to adopt the final map as required by the California Voting Rights Act. This report summarizes the timeline and events leading up to the final recommended action.

STAFF RECOMMENDATION

Motion: I move that the Board:

- 1. Adopt Resolution No. 2022-02 which establishes voting districts for the Board of Directors; and
- 2. Direct staff to work with the District consultant, Cooperative Strategies, and the County Elections office to have the districting map integrated into the countywide voting system.

DISCUSSION

Background

The District started the process to comply with the California Voting Rights Acton on January 7, 2021. The Board adopted Resolution No. 2021-01 declaring its intention to transition from at-large to division-based elections for the Board of Directors commencing with the General Election in November 2022. To meet the requirements of Elections Code Section 10010, the District conducted two (2) Public Hearings over a period of no more than thirty (30) days, at which time the public was invited to provide input regarding the composition of said area boundaries. Those meetings were held on August 5, and September 2, 2021.

At public hearing three, the Board reviewed the 2020 census data and three prospective area boundary scenarios. The Board provided input to staff and the demographer on modifications to Map 2 which resulted in the development of three additional map scenarios, 2A, 2B and 2C. At public hearing four, the Board reviewed the three original maps and the new scenarios. The Board requested that Maps 3 and 2A be brought back for further consideration and deliberation. At public hearing five, the Board reviewed the map scenarios 2A and 3 and selected a revised map 3 (Map 3A) as the final map.

RESOLUTION 2022-02

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE LOS OSOS COMMUNITY SERVICES DISTRICT ESTABLISHING VOTING DIVISIONS FOR ELECTIONS AND DEFINING DIVISION BOUNDARIES PURSUANT TO ELECTIONS CODE SECTIONS 10010 AND 10650

WHEREAS, the Los Osos Community Services District ("District") currently elects and is governed by five board members using an at-large election system; and

WHEREAS, subdivision (a) of Elections Code section 10650 authorizes a special district to, by resolution, require that the members of its governing body be elected using district-based elections without being required to submit the resolution to the voters for approval, in furtherance of the purposes of the California Voting Rights Act of 2001 ("CVRA"); and

WHEREAS, at its January 7, 2021, meeting, the District adopted Resolution No. 2021-01, a resolution of intent to establish a by-division voting process pursuant to Government Code section 10010, and the District subsequently hired a demographer to assist in the process; and

WHEREAS, in accordance with Elections Code section 10010, the District held two (2) public hearings (August 5, 2021 and September 2, 2021) before any maps of voting districts were drawn, at which time input from the public on the proposed composition of the voting districts was invited and heard; and

WHEREAS, on October 7, 2021, three (3) voting maps were presented and discussed at a public hearing at which the public was invited to provide input regarding communities of interest and other local factors; and

WHEREAS, on November 4, 2021, the District held a fourth public hearing to consider the three (3) map scenarios in addition to three variations of what was identified as "Map Scenario 2," and public input was again invited and heard; and

WHEREAS, on December 2, 2021, the District held a fifth public hearing at which the District Board at which public input was invited and heard, and the District Board made a final map selection to be brought back to the Board for adoption; and

WHEREAS, it is the position of the District Board of Directors that the map attached hereto as Exhibit A, will best serve the interests of the Los Osos Community Services District and is consistent with the California Voting Rights Act and applicable law; and

WHEREAS, the purpose of this Resolution is to enact, pursuant to Government Code section 10650, a resolution providing for the by-division election of the Directors of the Board of Directors of the Los Osos Community Services District; and

WHEREAS, all other legal prerequisites to the adoption of this Resolution have occurred.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Directors of the Los Osos Community Services District, as follows:

- 1. The above recitals are true and correct and incorporated herein by this reference.
- 2. To further the purposes of the California Voting Rights Act of 2001, the Board of Directors of the Los Osos Community Services District hereby approves the division boundary map included as Exhibit "A" to this Resolution. Beginning with the November 2022 election, members of the


Board shall be elected on a division-based electoral system from five single-member Board divisions as shown on the attached map.

- 3. The General Manager and District Legal Counsel are hereby authorized and directed to take the steps necessary to implement this Resolution.
- 4. This Resolution is effective on the day of its adoption.




