DISCUSSION

District Accountant Robert Stilts, CPA

On March 29, 2017, the Rate Study Group presented the Board with implementation procedures regarding the property tax that Fund 500/Water receives from the County:

Unit Chief Scott M. Jalbert "Reallocate property tax revenue from the water fund to funds within a district wide benefit in the following percentages; 25% reduction in FY 17/18, additional 12.5% reduction in FY 18/19, and additional 12.5% reduction in FY 19/20, for a total of 50% over three years."

In Fiscal Year 2017/2018, 25% of the Water Property tax fund was given to Fund 301/Fire. In the 2018/2019 Fiscal Budget, Fund 301/Fire received 25% and Fund 800/Drainage received 12.5% of the Water Property tax. The Parks and Recreation Chairperson and staff are requesting 25% be allocated to Fund 301/Fire and 25% be allocated to Fund 900/Parks and Recreation.

Box 6064 Los Osos, CA 93412 In order to accomplish Parks and Recreation goals within the District, there needs to be a consistent flow of revenue to maintain any parks or recreation established by the Parks and Recreation Committee. The funds would be used towards operations and maintenance of Parks and would assist with any future Dog Park goals.

Staff is requesting 25% (\$63,430.50) of the Water Property tax be allocated to the Parks and Recreation Fund for operations and maintenance use.
