A RESOLUTION OF THE BOARD OF DIRECTORS OF THE LOS OSOS COMMUNITY SERVICES DISTRICT TERMINATING THE CONSULTING AGREEMENT WITH WARMERDAM CPA GROUP FOR ACCOUNTING AND BOOKEEPING SERVICES

WHEREAS, California Government Code Section 61060(g) allows the Board of Directors of a community services district to contract for professional services, including but not limited to accounting and bookkeeping services that fit the needs of the District; and

WHEREAS, the Los Osos Community Services District Board of Directors (Board) contracted with Warmerdam CPA Group on April 1, 2016 to provide specified bookkeeping and accounting services, and

WHEREAS Paragraph 3 of said contract provides that the contract may be terminated at will by the Resolution of the Board of Directors; and

WHEREAS, the Board of Directors has determined that it is desirable to abandon prosecution of the Work by Warmerdam CPA Group as of January 31, 2017.

NOW, THEREFORE, BE IT RESOLVED that the Los Osos Community Services District Board of Directors does hereby terminate the aforementioned contract effective January 31, 2017; and

BE IT FURTHER RESOLVED, that the General Manager is hereby authorized to ensure full payment for all services performed according to Paragraph D of said contract
