District/CAL FIRE Chief Report for April 2019

EMERGENCY ACTIVITY

1. Station 15 - South Bay responded to 116 calls between March 19th – April 21st, including 81 Medical Aids, 1 Surf Rescue and 4 Traffic Collisions; 0 incidents were reported as Fire, 6 as Hazardous; 18 as Public Service Assists; and 6 as false alarms.

Company 15 was called to cover the station or respond to emergencies 3 times between March 19th through April 21st.

ADMINISTRATION

2. During the month of March, Station 15 – South Bay Firefighters continued inspecting local business for their yearly safety inspections. This is an ongoing project they will continue throughout the year.
3. Station 15 – South Bay staff continued the budget preparation process through the month of April. Time was spent ensuring that the current budget was accurate and valid to provide a solid foundation for the next fiscal year budget.
4. On March 21, 2019, Reserve Firefighter Denver Chavez resigned after four years of service to the community of Los Osos. Denver accepted a position at the Redding Air Base as a helicopter firefighter.

SPECIAL PROGRAMS/PROJECTS

5. During the month of April, staff began collecting competitive price quotes to paint the outside of Station 15 – Station 15.


TRAINING
