STAFF RECOMMENDATION

The staff recommends that by motion the Board take the following action:

Motion: I move that the Board adopt Resolutions 2016-23, 2016-24, 2016-25, 2016-26, and 2016-27 to levy the assessments as listed separately in EXHIBIT A for Drainage, Fire, Bayridge Estates, Vista de Oro, and Wastewater Assessment District Service No. 1 assessments and direct staff to submit adopted resolutions and tax rolls to the County for collection.

DISCUSSION

Annually, various assessments are placed in the tax rolls for collection. In accordance with legislation and the County's rules, resolutions need to be adopted to legally place these in the tax rolls.

These assessments are individually listed in EXHIBIT A immediately following each applicable resolution. The rate or amounts for Vista de Oro, Bayridge, and Drainage Special Tax are the same as in prior years. The Fire Special Tax includes the 2.6% adjustment approved by the Board on June 2, 2016. The base assessments for the Wastewater Assessment District No. 1 includes an Administrative Charge of \$24.32 per parcel to cover trustee fees, assessment fees, assessment process fees and disclosure reporting and credit status maintenance. An administrative charge up to \$50 per parcel for bonds issued is allowed under the Municipal Improvement Act of 1913 and adopted in the District's Bond Resolution of 2002.

The bond assessments (for the Wastewater Assessment District No. 1) may vary by a few cents each year, due to the varying rates of maturing bonds, however, the total assessment for each parcel remains the same for the whole life of the bond which will all mature in 2034.

Assessment Lists. Due to the volume of the lists labeled as EXHIBIT A, only one hard copy was produced and is available for public review; the Board Clerk is holding this copy. The list is also available in electronic format. The assessments that are the subject of these resolutions are summarized below. Wastewater Bond Assessments only show the rates for an average single family residential unit. The recap below shows the Wastewater Assessment amount needed for debt service.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE LOS OSOS COMMUNITY SERVICES DISTRICT SETTING ASSESSMENTS FOR SERVICES AT BAYRIDGE ESTATES AND DIRECTING THEIR COLLECTION BY THE COUNTY IN THE FISCAL YEAR 2016/2017 TAX ROLL

WHEREAS, the Los Osos Community Services District ("District") is a community services district organized under California Law under Govt. Code § 61000 et. Seq.; and

WHEREAS, the Los Osos Community Services District ("District") became effective on January 1, 1999, pursuant to an election and Resolution No. 98-239 of the Board of Supervisors of the County of San Luis Obispo, and

WHEREAS, by said Resolution and the resulting election, the Los Osos Community Services District is now authorized to exercise all of the powers, with all of the authority and responsibilities, that County Service Area No. 9 exercised prior to January 1, 1999, except the Cooperative Road Program and Fire and Emergency Medical for Zone I; and

WHEREAS, the San Luis Obispo County Board of Supervisors previously established and fixed annual service charge for central septic and street lighting services within the Los Osos Community Services District within this subdivision named Bayridge Estates which is a part of Los Osos Community Services District; and

WHEREAS, the Los Osos Community Services Districts are authorized under Government Code §61100(b) and (g) to have as its purpose the collection, treatment, or disposal of sewage generated and to maintain and operate street lights within the District's boundary respectively; and

WHEREAS, the Los Osos Community Services District is authorized under Health and Safety Code §6951 to operate a central septic system; and

WHEREAS, the Los Osos Community Services District is authorized under Government Code §61621 and §61621.2 to prescribe and collect rates and other charges for services provided by the District and to collect such charges on the tax rolls; and

WHEREAS, Bayridge Estates is within the Los Osos Community Services District and receives lighting and has a central septic system that is serviced by the District; and

WHEREAS, the Los Osos Community Services District has determined in prior years that the procedure for collection of annual service charges on the County tax roll for costs of certain services is the most advantageous procedure for the District to use and such determination is hereby affirmed; and

WHEREAS, the Board held a public hearing in its special meeting on June 20, 2013 at the time and place for which notice was given, which concluded a public hearing process held in accordance with California Constitution Article XIIId regarding a proposed increase of \$172 per parcel per year and at which meeting a majority protest did not occur and the increased fees passed by majority vote.

WHEREAS, this resolution is for the purpose of continuing to levy charges for central septic services and street lighting in the Bayridge Estates subdivision; and

NOW, THEREFORE, BE IT RESOLVED, DECLARED, DETERMINED AND ORDERED BY THE BOARD OF DIRECTORS OF THE LOS OSOS COMMUNITY SERVICES DISTRICT AS FOLLOWS:

- 1. That the findings and recitals in Paragraphs 1 through 12 are true and correct; and
- That the Board of Directors hereby confirms and levies each individual service charge of \$373.00 per parcel for Fiscal Year 2016/2017 on all properties within Bayridge Estates for the purpose of funding central septic operations and street lighting within Bayridge Estates; and
- That this service charge on the parcels of real property within Bayridge Estates shall be established, imposed and levied in the amounts as listed in EXHIBIT A and as so confirmed shall appear as separate items on the Fiscal Year 2016/2017 tax bill of each parcel of property so listed; and

RESOLUTION OF THE BOARD OF DIRECTORS
OF THE LOS OSOS COMMUNITY SERVICES DISTRICT
SETTING ASSESSMENTS FOR THE SPECIAL FIRE TAX
FOR PURPOSES OF FIRE PROTECTION AND PREVENTION
AND DIRECTING THEIR COLLECTION BY THE COUNTY
IN THE FISCAL YEAR 2016/2017 TAX ROLL

WHEREAS, the Los Osos Community Services District ("District") pursuant to Government Code §53978 is authorized to provide fire protection services; and

WHEREAS, the voters of the Los Osos Community Services District ("District") approved Measure A-05 that adopted Ordinance 2005-01 that repealed the prior special tax and adopted a new special tax for the purposes of obtaining, furnishing, operating and maintaining fire department equipment and/or apparatus, real property and facilities, for fire protection services, rescue services, emergency response services and other services relating to the personnel and for no other purpose; and

WHEREAS, Ordinance 2005-01, Section 6 provides as follows:

MAXIMUM TAX AMOUNTS. The maximum amount of tax imposed on each parcel pursuant to this ordinance shall be determined as follows:

A. Commencing fiscal year 2005/2006 a maximum special tax rate of Thirteen Dollars and Fifty-Two Cents (\$13.52) per unit of benefit, to be adjusted each year thereafter not to exceed the average of the percentage changes in the Consumer Price Index (CPI) for all items for the San Francisco/Oakland/San Jose and the Consumer Price Index for all items in Los Angeles/Anaheim/ Riverside at June 30 of the current year over the previous year's average of those indexes on the same date.

WHEREAS, in accordance with the formula contained in the ordinance, the Board approved the implementation of the Consumer Price Index (CPI) increase to the Fire Special Tax for the Fiscal Year 2016/2017 at their June 2, 2016 meeting; and

WHEREAS, the average percentage change in the Consumer Price Index for the period from December 31, 2014 to December 31, 2015 has been determined to be an increase of 2.6% or forty cents (\$0.40) setting the rate to sixteen dollars and sixteen cents (\$16.16) per unit of benefit, exhibited as follows:

WHEREAS, the Board held a hearing on this date pursuant to a published notice and before the adoption of this resolution to receive public input, including any objections to adopting the proposed increase on the rate and setting the Special Fire Tax rate for Fiscal Year 2016/2017.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE LOS OSOS COMMUNITY SERVICES DISTRICT DOES HEREBY RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

- 1. That the findings and recitations in Paragraphs 1 through 10 are true and correct;
- That the Board of Directors hereby confirms and levies the Special Fire Tax on all
 properties within the Los Osos Community Services District a rate of Sixteen Dollars
 and Sixteen Cents (\$16.16) per unit of benefit for the Fiscal Year 2016/12017, in
 accordance with the Schedule of Benefits listed above; and
- That this special tax on the parcels of real property within the Los Osos Community Services District shall be established, imposed and levied in the amounts as listed in

EXHIBIT A and as so confirmed shall appear as separate items on the Fiscal Year 2016/2017 tax bill of each parcel of property so listed; and

 That said special tax shall be collected at the same time and in the same manner as general taxes levied for collection by the County pursuant to Government Code §61115(b).

Wastewater Assessment District No. 1

In accordance with the Limited Obligation Improvement Bonds Debt Service Schedule, the District will need to collect \$1,156,750 for the March 2, 2017 and September 2, 2017 payments (Year 15).

The amount collected through FY 16/17 Property Taxes is \$1,148,130.92. The difference is due to the forty four (44) APN's that fully paid their assessments after the discount period, and the five (5) common area parcels that are no longer subject to tax collection.

We are assuming that a portion of the above APN's assessment payments, currently being held in a LOCSD account, be used to make that APN's payment in Year 15.

Note: Due to engineering corrections, we will be collecting more money than initially required for Year 15 in the original final debt service schedule. This difference of \$1,967.72 will be reconciled at the end of the project.
